### **Elizabeth M. Roberson Receives the Indianapolis Bar Association's 2022 Young Lawyer of the Year Award**

The Young Lawyers Division of the Indianapolis Bar Association selects each year a "Young Lawyer of the Year" based on meeting specific criteria established by the IndyBar. The attorney receiving the award must be 36 years of age or younger OR have been in practice eight years or less, be a member of the IndyBar, have made exceptional contributions to support Young Lawyers Division sponsored activities or programs, be recognized as a good role model for the legal profession and deserving of special recognition. The recipient is selected by the executive committee of the Young Lawyers Division.

Ms. Roberson has been integrally involved in the IndyBar for several years. She has served as a member of the Young Lawyers Division Executive Committee since 2017, currently serving as the Executive Committee Chair, and having served as past Social Chair and Chair Elect/Secretary-Treasurer. She was also the 2021 recipient of the IndyBar's Young Lawyers Division Distinguished Leadership Award. In her various roles on the Young Lawyers Division Executive Committee, Ms. Roberson has had the opportunity to mentor many young attorneys and serve as a voice for other young lawyers. Ms. Roberson also serves on the IndyBar Board of Directors and the Executive Committee of the IndyBar's Labor and Employment Section.
