Mr. Quigley has experience in a wide range of other litigation matters, including negligence, breach of contract, misappropriation of trade secrets, breach of fiduciary duty, fraud, conversion, covenants not to compete, shareholder disputes, securities fraud, patent infringement, class actions, receiverships, preliminary injunctions and administrative law disputes.

Mr. Quigley regularly represents health care clients in a variety of matters, including defending *qui tam* claims under the False Claims Act. He also represents clients with respect to internal investigations and investigations by federal and state governmental authorities regarding a variety of topics, including compliance with the Anti-Kickback Statute, Stark Law, and Medicare and Medicaid reimbursement rules. Mr. Quigley also conducts compliance investigations and advises clients in developing and implementing effective compliance programs. In addition, Mr. Quigley assists clients negotiating and implementing Corporate Integrity Agreements with the Department of Health and Human Services, Office of Inspector General.

Mr. Quigley also dedicates a significant part of his practice to the defense of national manufacturers in product liability cases. In addition, Mr. Quigley regularly represents financial institutions in a variety of matters including lender liability, forgery, and conversion. Mr. Quigley also represents commercial real estate owners and property managers in various lease enforcement proceedings, including commercial evictions.

Mr. Quigley was a member of the defense team of a multi-district litigation (MDL) transferred to Indianapolis, which involved numerous class action claims and over eight hundred personal injury and wrongful death claims brought by plaintiffs from around the country. Mr. Quigley has handled several appeals before the Indiana Supreme Court, Indiana Court of Appeals and the Seventh Circuit Court of Appeals and has presented oral argument to the Indiana Supreme Court. Prior to entering the practice of law, Mr. Quigley served as a computer analyst with the largest consulting firm in the United States where he specialized in Change Management Consulting.
