Representative Experience

- Revised the sales tax collection process on gasoline sales to capture lost revenue for the state and ensure a level playing field for retailers
- Directed a coalition of retail interests in a grassroots campaign to change Indiana's alcoholic beverage laws, ultimately laying the groundwork for the legalization of Sunday alcohol sales
- Represented the country's largest gaming operator in their successful appeal to the Indiana Gaming Commission for approval of various casino license transfer applications.
